

SABBATH AT IRVINE REGIONAL PARK NEXT SABBATH,

APRIL 26 Next Sabbath our congregation (and some from Los Angeles and Redlands who will join us) will be able to enjoy another Sabbath in the Park (our 28th) at Irvine Regional Park in Orange. We have reserved the same secluded and beautiful Coyote Corner underneath a canopy of trees. There are plenty of picnic tables but you may bring your own lawn chairs if you would like. Note that the parking lots are basically in alphabetical order and we are in Parking Lot "O." There are two adjacent parking areas.

Services will be at 11:00 a.m. followed by a deli-type sandwich lunch. Our congregation again will provide all the sandwich fixings. We ask our attendees to bring a salad or side dish plus a dessert. A donation box will be there if you want to help defray some of the costs. After lunch, enjoy fellowshiping with each other in nature until you want to leave.

Directions to Irvine Regional Park at 1 Irvine Park Road in the city of Orange

Irvine Regional Park is located in Santiago Canyon, in the east part of the city of Orange. From the south you can take the Newport Freeway (#55) to the Chapman Avenue East offramp. Head east on Chapman for approximately five miles. Turn left on Jamboree for one fourth of a mile to the park entrance.

From the north you can also take the Katella Ave. exit from the 55 freeway. Katella becomes Villa Park Road which becomes Santiago Canyon Rd. Turn left at Jamboree which becomes Irvine Park Road.

There are other ways to reach the park, including going north on Jamboree or taking the 241 tollroad part of the way

FEAST OF TABERNACLES REGISTRATION – IMPORTANT **(Note: please see the UCG Home Office Weekly Update this past Thursday for more detailed info.)**

EARLY REGISTRATION FOR TEMECULA BEGINS TOMORROW AT 9:00 A.M.

To ensure that members from local congregations are approved appropriately, Feast registration will take place in two phases: early registration and general registration.

Early Registration for Restricted Sites: April 20, 9 a.m. PDT - April 26, 3 p.m. PDT

Early registration applies only to the following restricted sites:

Lihue, Hawaii; **Temecula, California**; and Walnut Creek, Ohio
Once registered during early registration, you may begin making housing reservations.

These sites are expected to reach capacity early on the general registration day of April 27.

A passcode is required to register each of these sites. The passcode for Temecula is available to those in our congregation.

Temecula and Lihue: These sites are expected to reach capacity within 15 minutes. Everyone registering for these restricted sites on April 27 will be placed on a waitlist. Applicants will receive an email (by later that afternoon or Monday) with the status of their request. Walnut Creek: You will receive either immediate approval or be wait-listed at the time of registration.

GENERAL REGISTRATION BEGINS A WEEK FROM

TOMORROW, APRIL 27 (Sunday) at 9 a.m. PDT for those who don't have to attend their closest site and are applying for another site. You may register for your closest site unless it is closed.

If you are attending any U.S. Feast site except for Lihue, Temecula or Walnut Creek, you may book housing now, as these sites are not expected to reach capacity. However, be sure to officially register on April 27.
