Feast of Tabernacles Updates

The Feast Webpage (feast.ucg.org) has been updated showing all current U.S. Feast sites. Regrettably four sites were cancelled due to the social distancing regulations that limited attendance. Those sites were: Lake Junaluska, Steamboat Springs, Bend / Redmond and Oceanside (plus, in the Caribbean, Suriname and Haiti are now officially cancelled).

Three new sites are available and can accommodate larger attendance with less stringent restrictions. Those sites are: Gatlinburg, TN, Rapid City, SD and St. George, UT.

Those who were registered at the cancelled sites were sent an email on Thursday evening, August 6, with instructions on how to update their registration information.

We realize that some members may not be able to attend live services and will make personal arrangements. However, there will still be at least two Feast sites in different time zones that will webcast live daily services.
