#### Feast of Tabernacles Announcements

Tomorrow, Sunday, April 18, anyone can begin making housing reservations at a Feast site they have been approved at except for Panama City Beach or Lake Junaluska. Reservation staff at Panama City Beach and Lake Junaluska have requested reservations wait until Tuesday, April 20, so they will be able to better handle the higher reservation traffic.

## (1) Wait List at Anchorage and Panama City Beach

Currently there is a wait list for Anchorage and Panama City Beach. As conditions change, it is hopeful that more people will be allowed to be approved, but there is no guarantee at this time. The Feast coordinators of those sites will send out an update in early May. Members should not make housing reservations at those sites until they are approved.

## (2) Housing Reservations Advisory

Hotel reservations normally only require a one or two-night deposit, and cancellation is usually without penalty until within a week of the Feast. Condominiums and homes normally require higher initial deposits and some are not refundable. Carefully review the cancellation policies of any condominium or homes before committing a deposit.

## (3) Airfare Advisory

There might be some great deals right now, but be sure you understand the cancellation policy. If an airline provides cancellation insurance, make sure of the allowable parameters to receive a refund. Coronavirus might not be included.

# **Prayer Requests:**

**From Monica Corirossi**. Alan and I would like to thank everyone for their prayers for his mom, Linda. Her surgery went well on Thursday. She will remain in the hospital at UW Madison for 5 to 10 days depending on her progress. She will be unable to talk for 3 weeks to give the surgical area time to heal.

We would also like to ask for prayers for Alan. His kidney function has not rebounded since his heart surgery back in July 2020. He has started peritoneal dialysis at home nightly. His doctor is in the process of having him added to the transplant list for a dual (kidney and pancreas) transplant as she feels that his kidneys will not rebound after such a lengthy time. He will remain on dialysis until the time of the transplant. We will be seeking a second opinion just to ensure we are on the right path.

Of course, we understand and know that God can do anything, so we are asking that He guide us along this path we are now on and give us both the strength and courage to make this journey. Thank you, Monica Corirossi

The Brock Family. Thank you all for your urgently needed prayers. The Family is pleased to inform all that while Samara spent several hours in ER on Wednesday the doctors were able to stabilize her and provide relief from the associated pain of COVID-19. While CPS was a genuine concern because of her low body weight exacerbated by the COVID, CPS was not at all involved after all. The hospital then sent her home to rest and recover from the COVID-19. Further good news is that she is now able to hold down fluids taken orally. As many of you know, Samara (now age 16) no longer has the direct problem of M.A.L.S., but because of several ongoing co-morbidity complications, Samara's immune system is seriously compromised so continued prayers are needed for recovery. Additionally, prior to the COVID infection, Samara has been stable, and is taking growth hormone shots to assist her overall recovery.

Further, Samara's mother is in a very difficult condition as well. Andrea's immune system is seriously depleted with a low white blood cell count and several other symptoms that have severely weakened her and involves full body pain. After biopsies and various tests, her condition remains unknown. Therefore, the prayers we're asking

for is: 1) that she have relief from pain while waiting for an official diagnosis and 2) that she is spared the CoVid-19 infection.
